The recommended salary is given to the Executive Committee of the Board of Directors, who make a motion for consideration by utilizing a salary survey, comparing against organizations similar in mission, regional area, size and scope of service. The recommended salary is prepared by the HR manager and given to the Executive Director for final review and approval.
